Batliboi & Associates LLP with effect from August 13, 2024 who will hold office till the conclusion of next annual general meeting of the Company.

Dear Sir,

We were appointed as statutory auditors of Easy Trip Planners Limited ("the Company") in 14th Annual General Meeting ("AGM") held on August 30, 2022, for a period of 5 years beginning April 01, 2022, till the conclusion of 19th AGM.

Further to email dated August 12, 2024 from Mr Ashish Bansal, Chief Financial Officer and copied to you, requesting us for a reduction of audit fee for the statutory audit for the year ended March 31, 2025 and reviews of financial results for the quarters ending September 30, 2024, December 31, 2024 and June 30, 2025, from Rs 1.50 crores to Rs 1.15 crores due to cost constraints, please refer to our discussions with you in this regard including our initial request for a fee increase of 20% for reasons discussed with you. Since we consider your proposed fees as significantly disproportionate to our audit efforts, it would be extremely difficult for us to continue as statutory auditors of the Company. Accordingly, we hereby tender our resignation as the statutory auditors of the Company and request you to treat this as our letter of resignation with immediate effect. We have also discussed this matter with the management of the Company.

Kindly take this on your record and do the needful. As required by Companies Act, 2013, we shall file a statement in Form ADT-3 in the due course and we forward a copy to the Company for record.

We have completed the audit of financial statements of the Company for the year ended March 31, 2024 and Limited review for the quarter ended June 30, 2024 vide audit report dated May 26, 2024 and August 13, 2024, respectively, and have not commenced the audit of the Company as at and for the year ended March 31, 2025 and Limited review for the quarter ended September 30, 2024.

We take this opportunity to reiterate our appreciation for the courtesies and co-operations extended to us by your organization.
